### 2016 ACTOR AGREEMENT

This agreement between Warner Haunts, LLC and \_\_\_\_\_, hereafter referred to as "Actor," is for the 2016 Halloween Season. (please print)

- 1) The rate of pay will be \$45.00 for Friday and Saturday nights, \$35.00 for Sunday nights.
- 2) Alcohol and drugs is **strictly prohibited** while on the grounds or in the haunted house whether working or not.
- 3) Management reserves the right to perform random drug testing to any Actor at any time during their employment at Devil's Dungeon/Haunted Hell/Death Row.
- 4) Actors must arrive at least one hour prior to opening for costumes and makeup.
- 5) Touching guests/patrons is **strictly prohibited**. Actor acknowledges management's rule to stay at least 3 (three) feet from patrons.
- 6) Inappropriate interactions with other employees (including fighting) are **strictly prohibited**.
- 7) If you show up for work intoxicated from drugs or alcohol, you will be immediately terminated.
- 8) Weapons are not allowed on the grounds or in the haunted attractions at any time.
- 9) Cell phones are NOT permitted in the building during operating hours. Cell phone use is limited to management designated break times ONLY.
- 10) Any practice or activity deemed unsafe by management is grounds for immediate termination.
- 11) Smoking is **strictly prohibited** in any and all areas of the haunted attractions, including restrooms.
- 12) **Profanity or vulgar language is strictly prohibited at any time while on the grounds or in the haunted attractions.**
- 13) Any employee who is terminated will not be allowed back onto the property.
- 14) **Actors are responsible for their assigned costumes, props, and scenes.** Damage to their scene (including props) or loss of haunted house property is the actor's responsibility. The cost to repair or replace damaged/lost property will come out of the actor's final pay.
- 15) Actors understand the physical requirements of working in a haunted house and fully recognize and agree that they are able to perform and do not hold management, Devil's Dungeon, Haunted Hell, Death Row, or Warner Haunts, LLC liable for injury or loss of personal property due to actor negligence.
